### OPGW Orders

INR 18.8 Mn from PGCIL

INR 4.1 Mn from a Power Utility Company

### Optical Fibre Cable Order

INR 20.1 Mn from East Central Railway

**Mumbai, 30<sup>th</sup> January 2026:** Systematic Industries Limited (SIL), a leading manufacturer of specialised steel wires, cables and optical fibre solutions, has secured orders for Optical Ground Wire (OPGW) and Optical Fibre Cables (OFC) and from PGCIL, railways, utility customers and thereby, reinforcing its strong position in India's EPC business, power transmission and railway communication segments.

The Company has secured an OPGW supply cum installation developmental order from Power Grid Corporation of India Ltd. (PGCIL) amounting to INR 18.8 Mn.
